Vertical Blind and accessories with installation	<u>Louvres</u> : The louvres shall be 100mm wide made of fabric woven from 100% polyester yarns and coated with fade resistant specially formulated polymer to ensure complete opacity with zero light transmittance. The louvres shall hang straight and flat without buckling or distortion. <u>Headrail</u> : The headrail shall be of extruded aluminium alloy measuring 45mm wide and 25mm high with a minimum wall thickness of 1.10mm. The headrail shall house all operating components of the blind and shall be powder paint coated. <u>Carriers</u> : The carriers shall be made of delrin acetal resin and traverse on two wheels along the guide slots in the headrail. Each carrier shall have a self-aligning worm and spur gear mechanism to provide	Per square metre	

		<p>a synchronized 180<sup>0</sup> louvre rotation by use of an aluminium alloy tilt rod functioning as a drive shaft between the control box and the carriers. The spacing of each carrier shall be controlled by a plastic spacer fixed to the carrier body providing a minimum louvre overlap of 14mm in the fully closed position.</p> <p><u>Control Box:</u> The control box shall house the planetary tilt gear hub for turning of the louvres and shall have rollers for traverse cord. An endless plastic chain shall synchronize and actuate 180<sup>0</sup> rotation by turning the tilt rod attached to the tilt gear sprocket on the one end and the non-operating cap on the other end. Louvres shall traverse left to right, right to left or split by means of the traverse cord.</p> <p><u>Other Hardware:</u> The louvres shall incorporate hem pockets at top and bottom sewn with monofilament clear thread for inserting hanger and bottom weight. Hanger shall be made of nylon and bottom weight shall be moulded from specially formulated polymer. Bottom weights shall be connected together on both sides with plastic bead link chain. The bottom weights shall be so designed to allow the link chain to move without any friction for complete closure of vanes.</p> <p>The traverse cord shall be tensioned by a cord weight, which shall be removable without detaching cord from headrail.</p> <p><u>Installation:</u> Installation brackets shall be made of spring tempered steel with a front flange and rear tab to snap-in at top of headrail.</p>
