A. Main Features of Group Mediclaim Policy GMC-2026-27:

Salasar Services (Insurance Brokers) Pvt Ltd is the mandated Broker and policy will be booked through them.

i. Cover for treatment: -

(a) Each Employee (irrespective of any age group) will be entitled to Family Floater Sum Insured.

(b) Quote to be given in **as per below mentioned Family Floater Sum Insured:**

i) **Rs. 5,00,000/-** (Rs Five Lakh only).

(c) **Corporate Floater (buffer) Sum Insured of Rs.10,00,000/-** to be utilized at the discretion and approval of the Competent Authority of KKHSOU for utilization of existing employees and their eligible dependents only.

. The **family of existing employees** means and includes dependent spouse, dependent sons, dependent daughters (including widows/unmarried daughters) and dependent parents (as per eligibility criteria of KKHSOU). Any revision in eligibility criteria for Parents/dependents inclusion/exclusion by KKHSOU Management during policy period needs to be considered for mid-term addition/ deletion of parents of regular employees.

ii. Existing family floater cover shall continue for residual family member of employee dying in harness till expiry of the policy.

iii. (a) **Pre-existing diseases/ailments, first 30 days waiting period and 1st, 2nd, 3rd& 4th year excluded diseases** are to be covered under the policy without any medical test for all employees including new additions during the currency of the policy.

b) The policy shall cover all types of hospitalization expenses anywhere in India without any co-payment clause.

B. Submission of Bid:

i) Techno-Commercial bid: -

- a) The terms of the bid are enumerated at **Annexure-A**. The bidders have to categorically confirm that their quotation covers to each and every point (Sl. No.1 to Sl. No.8) of enclosed Techno Commercial Bid without any deviation/ alteration and /or changes and/or modification. The bidders must confirm that they fully accept the terms and conditions stated in the Techno-commercial Bid. This would be signed by authorized signatory of the bidder.
- b) Be it kindly noted that any deviation / alteration and or changes of the said terms & conditions of the Techno Commercial Bid would render the quotation of bidders invalid and KKHSOU reserves the right to reject any defective offer/counter offer without assigning any reasons.

ii) Price bid (Annexure-B):-

The price bid **Annexure-B** shall be submitted as per the listed format.

The price should not be indicated in other ANNEXURES enclosed, otherwise the bid will be liable to be rejected.

C. Pre-Qualification Criteria (PQC) for the Insurance Companies who are eligible for bidding.

- (i) The Insurance Company must have been in operation in Indian market in the field of Medical & Health Insurance for a period of at least two years as on tender opening date. Last 2 years IRDA payment (Financial Years) receipt is to be attached in support of fulfilling this criterion.
- (ii) The Insurance Company is presently handling at least two clients in the Central /State Public Sector Undertaking or/and Central/ State Government in the area of Group / Group Floater Medical Insurance. Copies of work order/ proof of payment of premium/ Insurance policy issued is to be attached in support of fulfilling this criterion.
- (iii) The Insurance Company should have office in Guwahati. Tax copy of Guwahati Municipal Corporation or Electricity bill is to be attached in support of fulfilling this criterion.

D. Bidders may also please note the following:
