2. Please mention the enquiry no. & date on the top of the mother envelope.
3. Please submit copy of your Income Tax Number and copies of PAN with your offer.
4. Copy of firm registration certificate/license of manufacturer/dealership certificate.
5. GST registration certificate
6. Income tax return document

7. Cancellation of Tender – Not withstanding anything specified in this tender document, Purchaser/Institute in his sole discretion, unconditionally and without assigning any reasons, reserves the rights :
 - a) To accept OR reject lowest tender or any other tender or all the tenders
 - b) To accept any tender in full or in part
