

TEN RUPEES TO RES.10 INDIA NON JUDICIAL

This agreement is made on this 25th Day of August, 2013 between Vardhaman Mahaveer Open University, Kota, Rajasthan represented by the Registrar of the University (hereinafter called "The Licensee" and this expression shall include his successors and assignees) on the one part and the Krishna Kanta Handiqui State Open University, Guwahati, represented by its Registrar (hereinafter called "The Licenser" and this expression shall include his successors and assignees) on the other part.

WHEREAS THE licensee wishes to make use of the printed instructional material of Krishna Kanta Handiqui State Open University, Guwahati designed for the various courses namely 3 year Master of Computer Application (MCA), one year Diploma in Computer Hardware and Networking (DCHN), one year P.G. Diploma in Mass Communication (PGDMC), one year P.G. Diploma in Broadcast Journalism (PGDBJ), one year Diploma in Journalism and Mass Communication (DJMC) by way of acquisition of reproduction rights and supplying them to the learners for the courses offered by the licensee and the licenser wishes to grant licence for such purposes.

Krishna Kanta Handiqui State Open University The Licensee and Licenser herewith AGREE on the following terms:

- I. THE LICENSEE would enable the use of the instructional material of MCA, DCHN, PGDMC, PGDBJ and DJMC as specified in this agreement for the academic programmes/ ourses offered by the licensee for an initial period of three years, from the date of this agreement.
- II. The Licenser hereby grants to the Licensee acquisition of reproduction rights of the following Self learning material of MCA, DCHN, PGDMC, PGDBJ and DJMC for the use of the reproduced material among the learners enrolled with the Licensee University i.e, Vardhaman Mahaveer Open University only and a copy of the relevant material forms the part and parcel of this agreement document.
- III. The following terms and conditions govern the license being granted herewith:-

Registrar Vardhaman Mahanear Gren University Koto Press

The Licensee shall seek the reproduction rights of the complete course material. The Licenser will supply to the licensee a hard & a soft copy of all the course material of the said programmes to be used by the Licensee as a copy for further processing and printing at the cost to be borne by Licensee concerned.

No change in the text, including the print cover page, shall be made by the Licensee when the course material is reprinted except for the following:-

The print line, mentioning the name of the press where it has been printed should be substituted by a print line giving the name of the press which shall reprint it.

Due acknowledgement of the Licenser made by the Licensee, at a prominent place in each copy of the book.

The updating of data and/or error rectification as addendum/errata on separate sheet with prior permission of the Licenser.

- Printing of the logo of the Licensee in addition to that of the Licenser.
- No translation of the material into any other language shall be permissible under

this agreement. The Licensee may go for a separate agreement in case it intends to translate the material.

- The Licensee, while reprinting the material shall ensure that the print quality of the material is as per standards of the Licenser's study material in respect of quality of paper and printing, cover printing etc.
- A printed copy of the each reproduced self learning material of MCA, DCHN,
 PGDMC, PGDBJ and DJMC shall be provided to the Licenser by the Licensee immediately after print for record.



The Licensee shall pay to the Licenser the license fee for using its material. The amount of License Fee shall be equivalent to 10% of the course fee collected every year by the Licensee University for the programmes for which the course material is used. The licenser & Licensee shall have the right to review the amount of license fee and it shall be governed by the policies of the licenser and licensee universities.

The fee collected from the learners for the said programmes should not be less than the fee charged by the Licenser.

A copy of the fee structure announced by the Licensee University shall also be given to the Licenser University. The Licensee University shall periodically inform its annual enrolment for the said programmes.

The Licensee, while using the printed instructional material of the Licenser, may also use the supportive audio-visual cassettes prepared by the Licenser (if any).

- IV. Any breach of this agreement shall render the licence null and void. In such circumstances, the Licensee shall destroy all reprint copies made and show proof of such destruction by submitting to the Licenser a certificate of destruction, and refrain from making use of the reproduced material.
- V. The License shall be terminated, if it is found that the licensee university is not using the license

for the given purpose.

The License shall be terminated, if it is found that the Licensee University in connivance with the VI. printer is selling the material in the market or making the material available to other than the enrolled learners of the Licensee University.

VII. At the expiry of the term of this license/at the termination of the license, the Licensee shall either return or destroy the material. The Licensee University shall not use the reproduced material for any other purpose in any manner, and if it is found that the Licensee is still using the material after the expiry period, the appropriate recourse to a court of law shall be taken.

VIII. The Licenser reserves the right to insist on the relevant part of the audited statements of the Licensee, so as to ascertain the amount of fee collected for the concerned courses/programmes.

Copy rights in respect of the concerned course material are reserved with the Licenser. IX.

X. The dispute, if any, shall be subject to the court of law only, decided by the Licenser.
