Sir/Madam,

Inviting reference to the above subject, I have the honour to inform you that the Office of the Registrar General, India (ORGI) under MHA, Govt. of India (with Directorate of Census Operations in states) is mandated under Census Act, 1948 to conduct decennial population and house listing Census operations in India. As you may be aware that Census data is the only authenticated source which provides data at both macro and micro level for the entire country as a whole for use and analysis by the Government, the academicians and the researchers.

ORGI is contemplating to establish dedicated research centres in the State Universities/Institutes/Central Universities to provide access to published census data of Censuses 1991 to 2011 and onward as well as census micro-data (anonymised) for students/researchers, under a protected environment. The expenditure for setting up of workstations is to be borne by the respective university/institute itself. The supervision of functioning of workstations will be jointly exercised by the university/institute and concerned Directorate of Census Operations in the state.

ORGI has already set-up dedicated Census Data Research centres in 18 different Universities/Institutes throughout the country to promote research in academic institutions. JNU New Delhi, BHU Varanasi, ISI Kolkata & IIM Bangalore are among the Central Universities/premier institutions, where the workstations have been established.

It is to inform that after receipt of confirmation on willingness from the universities/institutes, further modalities for setting up the workstation will be shared by the ORGI.
